The School of Architecture consists of 67 full-time equivalent teaching staff, 347 undergraduates, 321 master's students, and 17 doctoral candidates. The school offers first-professional and academic undergraduate degrees in Architecture (B.Arch., B.S.A.S.) and Interior Design (B.S.I.D.), first-professional as well as post-professional and academic graduate degrees in Architecture (M.Arch., M.S.A.S., M.A. in Architectural History, Ph.D.), Community and Regional Planning (M.S.C.R.P., Ph.D.), a M.S. in Historic Preservation, a M.S. in Urban Design, a M.S. in Sustainable Design, and Landscape Architecture (M.L.A.). The school contains two research facilities: the Center for American Architecture and Design and the Center for Sustainable Development. As dean, with the support of my colleagues, I was responsible for the establishment of the Center for Sustainable Development, and the M.L.A. degree. I helped merge the Lady Bird Johnson Center with the University and the School (\$24 million gift) and create the Dallas Urban Laboratory. During my tenure, the School's endowments have grown from \$17 million to \$29 million. The School and the Architecture and Planning Library are housed in four extraordinary buildings in the heart of the University of Texas at Austin campus.
- 2000-2001 Executive Director, Greater Phoenix 2100, Office of the Vice Provost for Research, Arizona State University, leading a university-wide initiative on the future of the Phoenix metropolitan region.
- 1989-2001 Director, School of Planning and Landscape Architecture, College of Architecture and Environmental Design, Arizona State University, leading a 17 FTE faculty and 3 FTE staff (formerly chair, Department of Planning). As director, I was responsible with the support of my colleagues and dean for the initial accreditation and the reaccreditation of the graduate planning degree, the establishment of an undergraduate degree in landscape architecture, the initial accreditation of the landscape architecture degree, the renaming of an undergraduate degree to include the word "planning," the elevation of the department to school status, the revision of curricula, the development of strategic plans, and the increase of faculty from 6 to 17 and graduate environmental planning students from 40 to 80. From 1994 to 1999, an environmental resources program with 5 faculty, 25 M.S. students, and 80 B.S. students was part of the school. The program was transferred to a new campus. I also participated in the development of a college-wide, interdisciplinary Ph.D. in environmental design and planning program.
